SERIES 6: WHITEHORSE MINING RECORDER – INTRODUCTION

The files in Series 6 were obtained from the office of the Whitehorse Mining Recorder. They had been stored in the basement of the Federal Building in Whitehorse.

The earlier files in this series were probably part of the central registry system. The old central registry numbers appear in round brackets () in the inventory listing which follows.

Some time after the government moved from Dawson to Whitehorse in 1953 a new numbering system was set up in Whitehorse. The date when this new system was adopted is unknown. The Whitehorse Mining Recorder's file numbers appear in square brackets [].

Series 6 is composed largely of Yukon quartz mining files. The file numbers on these files are prefaced by Y.Q.

Other subjects included in Series 6 are: Yukon Consolidated Gold Company plans of power lines and ditches, water power grants, placer mining regulations, quartz regulations - grants and renewals, dredging regulations, hydraulic concessions, coal mining regulations, early placer rulings, mining complaints, royalty export taxes - weekly statements, geological, geophysical and geochemical reports, Emergency Gold Mining Assistance Act, failure of Bonanza Creek dam, placer registered documents, correspondence - mining recorders and inspectors, survey of mineral claims, British Yukon R.R. Copper Belt Spur Line, gold dust confiscated, Dawson Miners Union, Strikes, Agreements, quartz royalty and ore shipments, and files on other miscellaneous topics.

Old Central registry numbers appear in round brackets ().

Whitehorse Mining Recorder's records appear in square brackets [].

Yukon Quartz files are prefaced by Y.Q.
